Deadline: September 27, 2010

Entries and fees: must be received by the deadline date as **No** telephone entries will be accepted. Payment must be submitted to be confirmed in the tournament. Refunds will not be issued once the draws are made.

Format: Singles and Doubles. Single Elimination. Consolation for Singles only eliminated at the first round. All main draw matches will be best 2 out of 3 sets with a tiebreaker at 6 all in each set. In lieu of a 3rd set, a 10 point tiebreak will be used to determine the final score. A Pro Set format will be used in all consolation rounds leading to the finals where 2 out of 3 sets will be played with regular 7-point tiebreak format.

Draw and Refunds: The draws will be made and finalized one week prior to the tournament. Draws and start times will be posted on the GLTA website and also available at the Las Vegas Classic Welcome Party. Additional information may be found on the Las Vegas Gay Tennis Club website: www.lasvegsgaytennisclub.com.

Divisions: The tournament draw committee had the right to reclassify a player to a higher division in accordance with GLTA Rules and Regulations. The tournament draw committee reserves the right to compare available USTA ranking and other tournament match statistics.

Minimum Draw Size: If a division does not have a min of 8 Entries, it may be combined with another division. Entrants in a Cancelled division will be given the option of a refund or participation in another division.

Match Times: Match times will be available at the Welcome Party, on the GLTA website and at all tournament locations.

Seeding: Seeds will be determined by using GLTA ranking and other consideration may be given to recent and verifiable results in the USTA sanctioned tournaments, head to head records, or other pertinent information.

Welcome Party: The Welcome Party will take place on Thursday, September 30, 2010 at TBD Welcome PACKS and Tournament guides will be available at the Draw Party. Draws will also be posted.

Confirmation: Confirmation of entry will be sent via email or can be checked at GLTA.net

Schedule of Play: Play begins Friday, October 1, 2010 at 8am and continues thru Sunday, October 3, 2010 with both semis and finals in all divisions. Singles and doubles finals will be played on Sunday, October 3, 2010. Please make appropriate travel arrangements.

Defaults: A 15 minute default time will be strictly enforced for all matches. The USTA point penalty system will be enforced.

Inclement Weather: Las Vegas does not have inclement weather, but if for some reason there are weather problems, it may result in schedule changes. No-Add scoring or Pro Sets may be invoked in order to complete the tournament. No refunds will be given for inclement weather.
